



Recreational Vehicle Parking Rules & Regulations

1. Each Recreational Vehicle (RV) must arrive at the track on Friday, September 23, between 10am and 5pm. No refunds will be issued. RVs will not be allowed to leave the area until 5pm, Sunday September 25, or after the last race is completed. RV area speed limit is 5 mph.
2. Tow cars accompanying RV's may enter and exit the RV area and Naval Air Station North Island until 10pm on Friday and Saturday nights following the routes prescribed by Naval Base Coronado. All tow vehicles need the Recreational Vehicle overnight pass to get in and out of the base and event.
3. All RV's must be self-contained. The Navy does not permit any dumping, open flames, pets, bikes or the unauthorized sale of merchandise. Unduly loud or unreasonable noise is not permitted. Please observe quiet hours, including the operation of generators from 10pm to 7am.
4. Inasmuch as this event is being conducted on board a military installation, all event participants and spectators are subject to the provisions of all applicable regulations and directives of the military installation and are subject to search. While on board the military installation, all event participants and spectators shall conduct themselves in an orderly and proper manner. In the event a participant or spectator is found to be conducting himself or herself in an objectionable manner, or in a way deemed to be detrimental to the security, morale or best interest of the U.S. Navy, he or she will be removed from the military installation. **The following are not allowed on board the installation: fireworks or any other explosives/explosive devices; firearms, BB guns/rifles, ammunition, stun guns, switchblade knives, and other types of weapons (i.e., weapons used in martial arts, etc.); illicit/non-prescription drugs and narcotics and pets/animals.**
5. In the event that an event participant or spectator does not conform to the terms of this contract, San Diego Fleet Week Foundation and/or U.S. Navy have the right to remove the RV and the responsible person from the 2011 Coronado Speed Festival venue. All costs associated with removal will be born by the person names on the RV application. No Refunds will be issued to anyone who is asked to leave.
6. Parking space will be assigned by the 2011 Coronado Speed Festival, and can be changed only with the permission of the Festival's Event Manager.
7. Additional rules and regulations may apply.

RV parking fee includes general admission tickets for (2) people for both Saturday and Sunday events. Each RV occupant must possess event tickets. RV spaces are given on a first come first serve basis. No Exceptions.
